

Clark County Lobbyist Registration Statement

(Note: This document becomes a public record once it is received by Clark County.)

Pursuant to Clark County 2.39 which states in part that: Every person who acts as a lobbyist shall, not later than five (5) days after the beginning of the activity, file a registration statement with the County Clerk, Commission Division.

- If registering as an annual lobbyist, this form must be completed once in its entirety. For all subsequent communication, lobbyist need only complete a **Disclosure Form**. Registration statements for annual lobbyists are due no later than January 10th of each calendar year.
- For lobbyist not registered annually, this form must be completed in its entirety for each communication along with a **Disclosure Form**.


